- A **separate** application is required for **each** camper seeking assistance.
- Funding is limited and awarded on a first come-first serve basis; please apply as early as possible.

Assessment and Award Process

1. Financial assistance is awarded based on a number of criteria including financial need, special family circumstances, session capacity, and the amount of funds available. We also use the State and Federal scale for free and reduced lunch to guide our decisions.
2. We will be reviewing applications in the fall and continue to review applications on a rolling basis until funds run out.
